**RESERVATIONS:** All seats are reserved. Reservations are tentative unless tickets are purchased at or before the time specified by the company when it confirms your space. Please make reservations well in advance with the nearest office listed inside folder, or with your local Travel Agent. If your plans change, please cancel your reservation early.

**RECONFIRMATION:** Reservations (including the complete remaining itinerary) will be cancelled:

1. when the passenger's planned arrival at such point is on a date earlier than his scheduled flight departure date and there is AT LEAST TWELVE (12) HOURS between his planned arrival and his scheduled departure; or
2. when the passenger's arrival at such point is indefinite because he has not determined his means of arriving transportation and not so advised the company AT LEAST SIX (6) HOURS before his scheduled departure time from such point...

UNLESS the passenger RECONFIRMS his intention to use his reservation by communicating with the company at such point AT LEAST SIX (6) HOURS before his scheduled flight departure time.

**AIRPORT CHECK-IN TIME:** Lake Central will cancel the reservations of any ticketed passenger who fails to present himself for "check-in" at our airport ticket office ten (10) minutes before scheduled departure time of the flight on which the reservation is held. (At Chicago, Ill. and Detroit, Mich., the check-in time is 20 minutes.) Passengers NOT holding confirmed tickets for a flight on which a reservation is held, must claim their tickets FIFTEEN (15) MINUTES before scheduled departure time, or such seats will be cancelled and made available to other passengers.

**BAGGAGE:** Forty (40) pounds of baggage is carried free. Baggage in excess of this amount, including parcels, briefcases, portable typewriters and cameras will be charged for at published excess rates. Unless extra value is declared and charges are paid before departure, the company's liability for baggage is limited to \$100 per passenger or the actual value of the baggage, whichever is less.

**CHILDREN:** One child, under 2 and not occupying a seat, will be carried free for each passenger over 12 who pays the full adult fare. No child under 5 may travel alone, but children over 5 and under 8 may travel unaccompanied upon payment of the full adult fare. Children under 8, when accompanied by a passenger over 12, may travel at half fare. Children over 8 and under 12 may travel alone at half-fare.

**CANCELLATION:** The company reserves the right to cancel bookings before passage or enroute whenever such action is deemed advisable or necessary. In all events the passenger's sole recourse shall be the recovery of the fare covering the unused portion of the ticket.

**SCHEDULES:** Schedules shown are expected arrivals and departures, subject to change without notice. Schedules and connections are not guaranteed.
