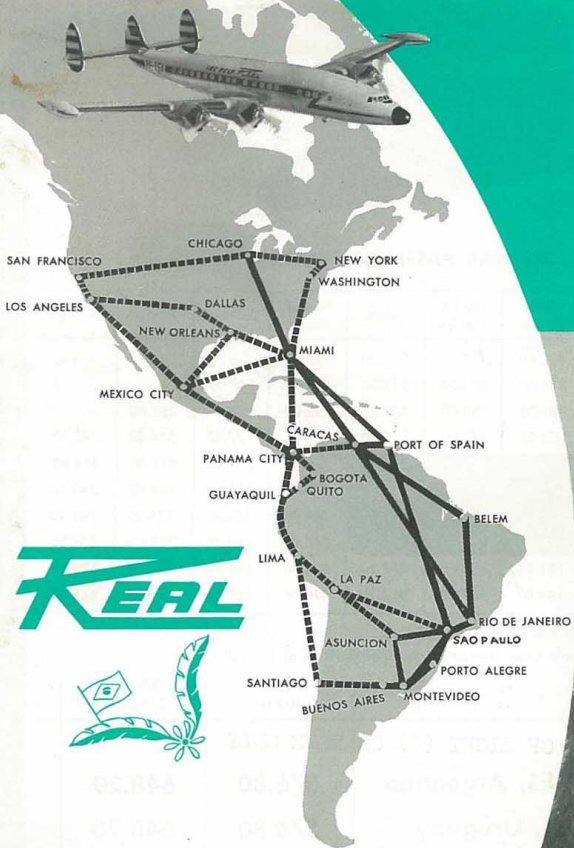
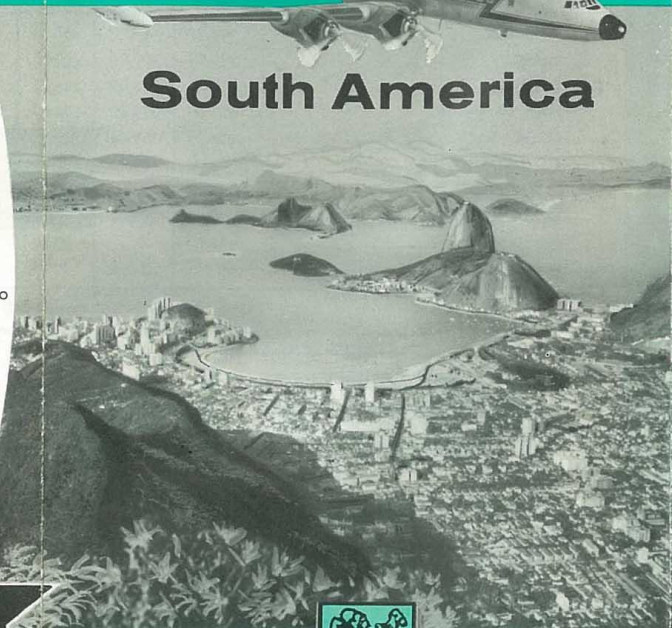

**PASSENGER INFORMATION**

The General Information shown below is subject to specific limitations and regulations contained in the official PASSENGER TARIFF of REAL AIRLINES (Brazilian International Airlines).

**SCHEDULES**—REAL reserves the right to cancel or change schedules without notice. Safety is our primary consideration. Schedules shown are based on expected flying times. Because weather and other factors may affect operating conditions, departures and arrivals can not be guaranteed.

**DEPARTURES**—There are certain governmental formalities which must be completed before an international flight may depart, and we must request that you arrive at the airport in time for the completion of these formalities. We reserve the right to cancel the reservation of any passenger who fails to present himself at the airport ticket office at least 45 minutes before scheduled departure time.

**TRAVEL DOCUMENTS**—Our agents gladly furnish information concerning passports and visas. However passengers are responsible for the validity of all documents. While we normally have available all the latest information, we are not responsible for its accuracy and urge you to consult the nearest consulate of the country you propose to visit in order to obtain official advice.

For those passengers who are Americans and travel to Brazil on a 30 days round trip excursion, the only documents necessary are two passport pictures, a valid passport, and smallpox vaccination certificate. Upon presentation of these papers, a tourist card is issued which is good for 30 days and for which there is no charge.

**TRAVEL FUNDS**—You are urged to carry the major portion of your funds in the form of Travelers' Cheques, Money Orders, Letters of Credit, etc. However, cash—preferably U. S. Dollars—in small denominations should also be available.

**CHILDREN AND INFANTS**—Children over 2 but under 12 years of age are carried at 50% of the published adult fare. Infants under 2 years of age, accompanied by an adult and not occupying a seat are carried at 10% of the normal adult fare.

**STOPOVERS**—Within the time limit of the ticket, stopovers will be permitted at any scheduled stop provided reservation is made and the passenger has a valid visa.

**MEALS**—Complimentary meals are served either aloft or on the ground.

**BAGGAGE**—Free weight allowance is 20 kilos (44 lbs.), which applies to children paying half fare as well as to adult. Excess baggage may be accepted at the rate of 1% of the One Way First Class Fare, per kilo (2.2 lbs.).

**CABIN AND CHECKED BAGGAGE**—Since checked baggage will not be available during flight, it is suggested that on flight which includes overnight travel you should carry a small overnight bag for toilet articles, etc., which you may carry in the cabin.

**LOCAL TRANSFER SERVICE**—Published fares apply from airport to airport. Transfer between airport named below and city pick up and delivery points in the cities shown below are not included in the fares.

**TAXES**—Transportation taxes are imposed by some governments. These are not included in the fares quoted and will be collected where they apply.

**RECONFIRMATION**

All reservations must be reconfirmed at least 48 hours prior to departure, otherwise they are automatically cancelled.

**How To Reconfirm**—Simply inform the airline at the city where you will board your continuing or return flight that you have arrived and intend to use your reservation. Do this at your earliest convenience, but be sure to reconfirm at least 48 hours before scheduled flight departure time.
